4D GOAT TYING Limited to 150 goat tyers

Eligibility : Contestants **must have** completed 6th grade to enter
2 go rounds (**NO Bonus Round** due to time constraints)

Intermission Ground Tying Goats will be held during the two rounds

Must compete in both rounds; May enter twice on same horse

1 (one) second split between divisions

NHSRA rules apply; **Contestants must wear western attire!**

- WHERE** South Dakota State Fairgrounds, Huron SD - North Arena by Gate 5
- CHECK IN** 11am – 12:30 pm- A table will be set up behind the crow's nest
- EXHIBITIONS** 10 am -11 am - \$5 at the gate
- STALLING** Reserve Stalling by calling 605.354.1633;
\$15 a night w/o shavings / \$20 night with shavings
- CAMPING** If you are a SD Timed Event Contestant you can camp on site;
If you are **not** entered in the SD Timed Event, camping will be off site.
Challenge contestants can stay at the Heartland arena. Limited stalling and hookups are available. Located about 1 mile east of Huron on Hwy 12.
- PARKING** Enter Gate 5; Parking will be to your left on the inside the Grand Stand Race Track area Only access to arena will be on foot/horse along the north fence line
- PAPERS** Health Papers Required: Out of State and South Dakota horses
Negative Coggins Required: Out of State horses
Please bring a second set of health papers for departure as they will keep a set upon check in

PARKING & CAMPING

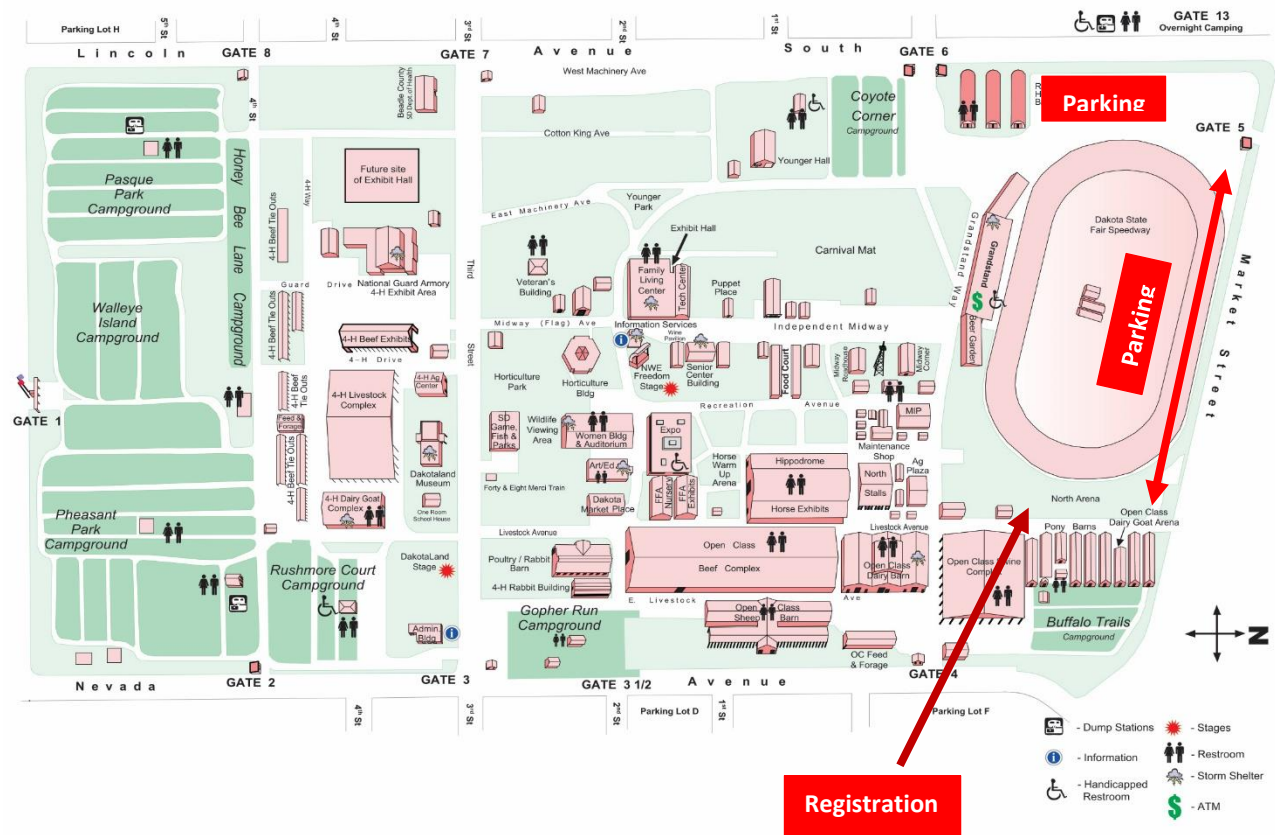
Starting at 11am on Friday, August 30, contestants may enter Gate 5 (located on the corner of Lincoln Avenue and Market Street on the northwest corner of the fairgrounds). Contestants that are only here for the Ty Tuff Challenge can park inside of the grandstand race track (see map). **Note: Due to contractual agreements with grandstand entertainers, all vehicles must be removed from the race track area by 7 PM or they will be towed.** For contestants also participating in the Timed Event Rodeo and planning on camping (dry camping only meaning no water or electric), are allowed in Gate 5 for the evenings of August 30 & 31. Camping is \$25/evening (pay at the gate as you enter along with gate admission).

NOTE: Once you have parked in Gate 5, the only access to the North Arena where the Ty Tuff Challenge is taking place is on foot (horse and person) along the north fence line. See map below:

Registration will be located below the announcer stand on the south end of the North Arena.



HEALTH PAPERS:

All animals will be required to present current health certificates upon arrival at the gate. Out of state horses will also be required to have a valid Negative Coggins. As the event gets closer, please verify health requirements with any current equine health outbreaks at <https://aib.sd.gov/>. Contestants responsibility to retain proper paperwork as original health papers will not be returned upon departure from grounds.
